

AGREEMENT

THIS AGREEMENT is made and entered into by and between Wild Card Outfitters, LLC of Creswell, North Carolina, hereinafter referred to as "Outfitter", and _____ hereinafter referred to as "Client." This Agreement shall be effective when Outfitter has received Client's deposit, and this agreement has been signed by Outfitter and Client. Furthermore, Outfitter agrees to maintain insurance as required by applicable law of the State of North Carolina and to provide client with a guided hunt during the dates of _____.

FEES AND PAYMENTS

In consideration of the services Outfitter has agreed to provide herein, Client agrees to pay Outfitter the sum of \$_____. A non-refundable deposit of \$_____ (50% of total hunt cost), concurrently with the execution of this Agreement; an additional balance of _____ (Final 50%) ON OR BEFORE the date of arrival. Client understands that in the event payment is not made as provided herein, Outfitter shall have the right at his sole discretion to cancel Client's hunt and terminate this Agreement, and retain all funds previously paid as liquidated damages and as his sole and exclusive remedy. Client understands that when Outfitter enters into this Agreement with Client, space is reserved for Client and said reservation could have been reserved for other potential clients.

RULES

Client hereby agrees to the following:

WOUND POLICY: If a client draws blood, the animal is considered dead and the tag filled. The hunt is terminated at that time. Wild Card Outfitters, LLC will make all reasonable efforts to track and/or recover a wounded animal, however, in the case recovery is not possible, Wild Card Outfitters, LLC claims no ethical or financial liability.

WEAPONS POLICY: No Loaded Guns in the Lodge or during transport to and from hunting area. Treat every gun as if it is loaded. Keep the muzzle pointed in a safe direction. Be sure that the barrel and action are clear of obstructions. Be sure of your target and what is front of and beyond it. Keep guns unloaded when not in use and action open. Point your firearm only at something you plan to shoot and avoid all horseplay with a gun. Do not run, jump or attempt to climb with a loaded gun. Keep your finger outside of the trigger guard until you are ready to shoot. Store firearms and ammunition separate and safely away from children and careless adults.

ALCOHOL/DRUG POLICY: Absolutely no alcoholic beverages are allowed before or during hunting. Detection of alcohol and/or drug use while in the field will be considered grounds for termination of the hunt and Outfitter will retain all funds previously paid as liquidated damages and as his sole and exclusive remedy.

THIS IS A WAIVER AND RELEASE OF LIABILITY. THE CLIENT HEREBY KNOWINGLY AND INTENTIONALLY WAIVES, RELEASES, INDEMNIFIES AND HOLD HARMLESS WILDCARD OUTFITTERS, LLC, THEIR DIRECTORS, OFFICERS, AGENTS, EMPLOYEES AND VOLUNTEERS from and against any and all claims, actions, causes of action, liabilities, suits, expenses, including reasonable attorney's fees, which are related to, arise out of, or are in any way connected with my participation in this activity including, but not limited to, NEGLIGENCE of any kind or nature, whether foreseen or unforeseen, arising directly or indirectly out of any damage, loss, injury, paralysis, or death to me or my property as a result of my engaging in these activities or the use of these services, animals or equipment, whether such damage, loss, injury, paralysis, or death results from negligence of hunting or from some other cause. I, for myself, my heirs, my successors, executors, and subrogees, further agree not to sue Wild Card Outfitters, LLC as a result of injury, paralysis, or death suffered in connection with my use and participation in the activities of hunting.

This Agreement is made in the State of North Carolina, County of Washington, and shall in all respects be governed in accordance with the laws of the State of North Carolina. Any action brought by either party to enforce any of the terms or conditions of this Agreement shall be brought only in Washington County, North Carolina. Each party consents to the jurisdiction and venue of Washington, County, North Carolina. IN WITNESS WHEREOF we have hereunto set our hand on the date indicated.
